Supervisor Hoyt reconvened the public hearing and went into the Town Board meeting at 7:00 pm. A motion to approve was made by Councilman Peters, 2^{nd} by Councilman Goettsche, with all in favor.

<u>THE MINUTES OF THE MARCH 27, 2025, TOWN BOARD MEETING</u> were approved as typed on a motion by Councilman Peters, 2nd by Councilman Walker, with all in favor.

GENERAL FUND RESOLUTION #10 OF 2025: the following resolution was proposed to transfer funds to balance the General Fund accounts. A motion to adopt this resolution was made by Councilman Goettsche, 2nd by Councilman Peters, with all in favor. AMBULANCE DISTRICT FUND RESOLUTION #5 OF 2025: the following resolution was proposed to transfer funds to balance the Ambulance Fund accounts. A motion to adopt this resolution was made by Councilman Peters, 2nd by Councilman Van Valin, with all in favor.

<u>9.AMBULANCE REPORT:</u> Ambulance Administrator Davia Montie was not present. As per a memo from the Bookkeeper, Cindy Nelson to Supervisor Hoyt; "the following ambulance employees are to be removed from active status on payroll... the Town of Windham Ambulance Service employees who have not been able to work for our service for some time. The following people are to be removed from the active employee roster; as the individuals either requested to be removed from the service list and/or failed to respond by the deadline: Thomas R. Borman and Ciaran O'Rourke". A motion to approve was made by Councilman Peters, 2nd by Councilman Walker, with all in favor.

<u>10.POLICE REPORT:</u> As per a memo from the Bookkeeper, Cindy Nelson to Supervisor Hoyt; "as per Civil Service, Michael Harte's employment title needs to be changed. His new title will be part-time "Administrative Aide" to the Police Department." A motion to approve was made by Councilman Peters, 2nd by Councilman Goettsche, with all in favor.

11.HIGHWAY REPORT: Highway Superintendent Gary Thorington was not present.

12.COMMITTEE REPORT: Councilman Walker will be attending two meetings one on April 21 and April 23, 2025. He will report on the meeting at the next town board meeting. Councilmen Van Valin, Goettsche and Peters have nothing to report on at this time. Supervisor Hoyt the mountaintop ambulance will be consolidating; this will be happening. It could happen as all employees would be under one-umbrella. There would be a maximum of 120 employees. This will be a work in progress; in stages. Once CD Lane Park is open there will be a clorination added to the water. Supervisor Hoyt has gone ahead to order new chairs and desks for the new police dept. All new office equipment has been ordered off the State bid. Michael Harte, Administrative Aide to the Police Dept has started on the police files sorting to be archived. Windham Chamber of Commerce Easter egg hunt has a rain date of April 13, 2025 @ 12 noon at the CD Lane Park.
