<u>7.AMBULANCE REPORT:</u> Ambulance Administrator Davia Montie was not present. In a memo from the Ambulance Administrator Davia Montie, Davia would like to recommend to the Town Board the hiring of Heather Younes as a part-time EMT for the Windham Ambulance. A motion to approve the new hire was made by Councilman Goettsche, 2<sup>nd</sup> by Councilman Walker, with 3 in favor, 2 absent.

8.ASSESSORS REPORT: the following Assessor's report was submitted to the Board for their review: "1.) Summer has arrived with some traffic. The sales market is filling. The good news is prices are holding. Stonewall Glen has started to take off with additional new sales, making it the most noticed property in Windham. Buildings and lots on South Street are gaining interest, as new parcels coming to market on South Street. The land sales/offerings are up. The Windham Mountain Club is gaining in the marketplace, drawing new conversations and opportunities. 2.) RPS our state sponsored real estate/taxation software is to be replaced within the next approximate year. Test sites have been picked, with the next wave being the offices that volunteer, who have particular settings (town size, parcel volume, technological set ups). I've let it be known, that Windham is ready to jump in. 3.) This year's SCAR, Small Claims Assessment Review in October and possibly November has three cases, one of which already has been successfully addressed...4.) Our technology/computer setup is doing well. We are able to review half dozen websites simultaneously. It allows us to handle odd information requests on the spot for walk-ins and call ins alike. We've now built photo inventories for garages, decks, drone views and construction. 5.) I would like to present my proposed budget. I have no new needs for the office or the department, and can confirm any Town Board needs or goals, at the August Town Board meeting. This would allow the Board to get my department out of the way, during your budget planning process. It will give me, time to supply those needs/goals, in writing if desired, prior to your appointment of the Town of Windham Assessor. Please let me know what you think of this, as reappointment is important to myself, my spouse and our taxpayers. I want to keep working in Windham."

<u>9.HIGHWAY REPORT:</u> Highway Superintendent Gary Thorington was not present. Town of Windham Begley Road has been completed. The highway dept is now working on the driveways and shoulders along Begley Road.

10.COMMITTEE REPORT: Councilman Walker has nothing at this time to report as the last CWT Meeting on July 21, 2025 was cancelled. Councilman Goettsche has nothing at this time to report on. Supervisor Hoyt has spoken with the Windham Chief of Police Rich Selner and with the Union Shop Stewart along with Civil Service; Michael Harte will be the SPO Officer where as needed. A motion to approve was made by Supervisor Hoyt, 2<sup>nd</sup> by Councilman Goettsche, with 3 in favor, 2 absent. CD Lane Park has been very busy. The residences are using the park well and keeping it clean after every event.
